Frequently Asked Questions:

1). ***What prerequisites do I need to qualify for Body Beautiful's training program?***

In order to be eligible to sign up for our training program you must be 18 years of age and have a state issued ID. You must have a high school diploma or GED equivalent. You do NOT need a Cosmetology or Esthetician license.

2). ***What type of Laser will I be trained on?***

Laser hair removal students will gain experience on the Diode and Nd: YAG. Students learning photofacials will gain experience with Intense Pulse Light (IPL).

3). ***How much do Laser Technicians earn?***

Every facility is different. At Body Beautiful our Laser Techs make an hourly wage, commissions on all skin care product sales, commission on sold services and tips. You can make as much as you are willing to work.

4.) ***Will the certificate I earn at Body Beautiful help me find employment?***

Absolutely! Our certificate is signed by a Medical Professional, Belal Abdallah, M.D. and provides documentation of your attendance, hours trained and the medical esthetic procedures you learned.

INSTRUCTIONS

- Arrive 15 minutes prior to your class start time. Class begins promptly on time.
- Bring all study materials, pen or pencil and paper for keeping notes.
- Wear comfortable clothing and dress in layers. Yoga pants, shorts and tank tops make it easy to access skin for Laser practice. There is NO dress code we want you to be comfy!
- Limit sun exposure and the use of tanning products 3-4 weeks prior to training. Lasers target pigment, the changing of one's natural skin tone could result in an ineffective or unpleasant treatment experience.
- Pack a lunch and a snack for each training day.
- Training is very hands-on and students will be performing and receiving medical aesthetic procedures; therefore, ONE WEEK prior to training avoid these products and/or procedures:
 - Electrolysis
 - Waxing
 - Depilatory Creams
 - Laser Hair Removal
 - BOTOX® injections
- TWO – THREE DAYS BEFORE avoid these products and/or procedures:
 - Retin-A®, Renova®, Differin®, Tazorac®
 - Any products containing retinol, alpha-hydroxy acid (AHA) or beta-hydroxy (BHA), or benzoyl peroxide
 - Any exfoliating products that may be drying or irritating
 - Cosmetic facial treatments or procedures (e.g. laser therapy, surgical procedures, cosmetic filler, microdermabrasion, etc.)
